

GENERAL RULES AND CONDITIONS OF PROBATION

SANDUSKY COUNTY COUNTY COURTS

IT IS THE ORDER OF THIS COURT THAT YOU **SHALL** COMPLY WITH THE FOLLOWING GENERAL CONDITIONS OF PROBATION:

PLEASE INITIAL EACH TERM OF PROBATION AND SIGN

 1. You **SHALL** obey all Federal, State, and Local Laws and Ordinances, including Chapter 2923 of the Ohio Revised Code relating to conduct involving firearms and other deadly weapons. You **SHALL** comply with all orders, rules, and regulations of Sandusky County County Court, with general good behavior.

 2. You **SHALL** not leave the state of Ohio or change your place of residence without the written or verbal consent of the Court or Probation Department; You **SHALL** always keep your probation Officer informed of your residence, phone number, and employment.

 3. You **SHALL** not use, possess, or have under your control any firearm or device that could be considered a dangerous weapon.

 4. You **SHALL** not use, possess, purchase, sell, or distribute any controlled substance or be in the company of any individuals in possession of any controlled substance. This includes, but is not limited to, instruments to administer them unless prescribed to you by a licensed physician. You agree to inform the Probation Department of any medications prescribed to you.

 5. You **SHALL** not use alcohol or marijuana while on supervision. At any time, you are subject to testing for the detection of illegal/legal drug usage or alcohol consumption. You **SHALL** not visit establishments where the sale of liquor or marijuana is the main business.

 6. You **SHALL** pay all court ordered financial sanctions or obligations (e.g., fines, costs, restitution, electronic monitoring fees) plus probation fees of \$250.00 for active probation or \$100.00 for inactive probation, within the time period agreed, or complete community service in lieu of financial obligations if permitted by the court.

 7. You **MUST** submit to a search by any authorized probation officer at any time when the officer has reasonable grounds to believe that you are not abiding by the law or otherwise are not complying with the conditions of your probation. (*Pursuant to Section 2951.02 of the Ohio Revised Code, Sandusky County County Court Probation officers may conduct warrantless searches of your person, your place of residence, any motor vehicle, item of tangible or intangible personal property, or other real property in which you have a right, title, or interest to use, occupy, or possess.*)

 8. You **SHALL** immediately report to your Probation Officer if you are arrested, detained, or questioned by any law enforcement.

____ 9. You **SHALL** promptly and truthfully answer questions directed to you by Probation.

____ 10. You **SHALL** report to the Probation Department as ordered and obey all special orders imposed upon you by the Court or Probation Officer.

____ 11. If your sentence involves a period of Electronic Home Arrest or Alcohol Monitoring, destroying or damaging any equipment may result in new charges (such as, but not limited to, felony vandalism or felony escape) in addition to any sanctions due to a violation of the terms of your probation.

____ 12. You **SHALL** not associate with persons who could influence you to engage in criminal activity.

____ 13. You **SHALL** become and remain gainfully employed and support your legal dependents. If you should become unemployed, you **SHALL** seek to become employed.

____ 14. If you are sentenced to serve a period of incarceration in the local county jail or other local facilities, and you are found to have violated any rules of said facility, you **SHALL** be considered in violation of your probation.

____ 15. If you are referred to an agency for evaluation/treatment, you **SHALL** successfully complete any recommended programming.

____ 16. The Court or Probation Officer may modify your conditions of probation at any time if it is deemed necessary.

____ 17. The Court will impose a \$10.00 fee to any person who is drug tested to be added to the court costs.
